**OBSTACLES AND RING CONDITIONS**

**Obstacles** meet the specifications for obstacles in the current edition of the Regulations for Agility Trials. All classes will take place indoors on a packed dirt surface. The rings are 100 x 90 (9,000 sq. ft.). The building is neither heated nor air-conditioned.

**DOGS ELIGIBLE TO ENTER**

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or approved Foundation Stock Service (FSS) breeds are eligible to participate. Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) number must be spayed or neutered in order to compete. Wherever the word "dog" is used it includes both sexes. Dogs should be physically sound. Dogs that are blind or deaf shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate. Puppies under six months of age are strictly prohibited from the trial grounds.

## DIRECTIONS TO THE TRIAL SITE

The town of McKinney is about 33 miles northeast of downtown Dallas on U.S. 75/North Central Expressway. From the north or south: On U.S. 75, take the U.S. 380 exit and go west about 2.5 miles to FM 1461. Turn right (north) on FM 1461 and travel approximately 3.8 miles to County Road 166. Turn right (north) on County Road 166 and go about 0.8 miles to the site which is on the left. The county has posted directional signs to the Event Center. Maps & directions also will be included in the Judging Program.

The exhibitor is fully responsible for entering the dog in the correct class(es)/height divisions. Dogs running in a lower height division than they are eligible for will be eliminated.

### MEASURING & HEIGHT CARD INFORMATION

Effective January 1, 2010, exhibitors are no longer required to provide proof to Trial Secretaries that their dog has a valid jump height card as part of the check-in process. Furthermore, this change eliminates the need for a copy of the jump height card to be submitted with an entry form. Dogs without a valid Jump Height Card/Form may still compete; but they must be measured/wicketed by the **Judge of Record** PRIOR to running in their class and this measurement will be valid for that weekend of trials only. The exception to this requirement is a dog entered in the 24" or 26" height division. However, if a **Volunteer Measuring Official (VMO)** or an **Agility Field Rep** is present; **ALL** dogs without a valid Jump Height Card/Form must be measured at some time during the trial or cluster of trials. This does not preclude having the dog wicketed by the Judge of Record if the VMO or Rep is not available to measure the dog **before** its first run of the trial or cluster of trials. It is the exhibitor's responsibility to have their dog measured prior to running and failure to do so will result in the cancellation of any qualifying scores.

#### NEW Simplified Jump Height Card Process

When filling out the entry form, there is a section at the top of the form for exhibitors to designate whether the dog has a valid jump height card or if the dog needs to be measured. Please check the appropriate box so that the Trial Secretary knows whether to include the dog entered on the *Dogs To Be Measured List*. **It is no longer required that a copy of a dog's jump height card be submitted with an entry form or show it at check-in; although exhibitors are required to have the official form/card with them at the trial to present upon request.**

### COURSE WALK-THROUGHS AND WARM-UP INFORMATION

**Handlers in all classes** are permitted to walk the course, without a dog, during a walk-through period held prior to the start of the class. The walk-through is restricted to handlers entered in that class only.

A **warm-up area**, consisting of a regulation agility jump, may be provided for exhibitors. The warm-up area is to be used exclusively for warming up the dog and not for training or relieving of the dog.

### RIBBONS, AWARDS, AND PRIZES

Rosettes will be awarded in each jump height division in each class as follows:

*First Place*.....*Blue*  
*Second Place*.....*Red*  
*Third Place*.....*Yellow*  
*Fourth Place*.....*White*  
*Qualifying Score*..... *Green strip ribbon*

A New Title rosette will be awarded to all dog and handler teams finishing a title. A MACH & PACH rosette and decorated MACH bar will be awarded to all dog and handler teams that attain their MACH or PACH. A coupon valued at five dollars will be awarded to all dogs that place 1<sup>st</sup> in their respective height and class. The club reserves the right to substitute a prize of equal value.

### NOTICE TO EXHIBITORS

**SAFETY, BEHAVIOR and LIABILITY:** The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely. **It is expressly understood** that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. DFWESSA and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. DFWESSA reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the DFWESSA or any official thereof. **All dogs must be on leash** at all times when on trial grounds except when in the designated warm-up area or competing on the course.

**REFUNDS:** No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. **Bitches in season** are not permitted to compete in Agility Trials. The club will offer a full refund less \$5 per day processing fee for bitches that come into season after the closing date. Notification in writing to the trial secretary must be made prior to the beginning of classes on the first day of the trial.

**RINGSIDE:** Dogs may arrive any time prior to judging, if a valid copy of their jump height card was sent with their entry. Otherwise, they must be available for measuring prior to the start of their class. **Judges are not required** to wait for dogs. The owner of each dog is solely responsible for having it ready at ringside when it is to be judged. The Club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

### TRIAL HOURS

The building will be open to exhibitors at 7:00 am on Friday with check-in at 8:00 am. Judging will begin on Friday no earlier than 8:30 am. The building will be open to exhibitors at 6:30 am for Saturday & Sunday. Self-service check-in will begin at 7:00 am both days. Excellent class judging will begin no earlier than 8:00 am. Exact running order will be determined after entries close and will be provided in the Judging Program. Running order will be determined by computer-generated random draw. There will be one ring on Friday and two rings will be running simultaneously on Saturday & Sunday.

### ADDITIONAL SITE INFORMATION

- Dogs **MUST** be kept on leash at all times at the trial site except within the designated practice jump areas and in the ring.
- All dogs **MUST** be crated when not in the ring
- Crating will be on dirt; mats are allowed (and encouraged) at this site.
- No propane heaters are allowed at this site.
- Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Trial Committee deems the exhibitor to be in violation of this requirement.

**INSTRUCTIONS**

Handlers may opt to enter in a higher height division for all Regular titling classes, but not in a division lower than their proper height division. Dogs entered in the Preferred classes must compete at the required jump height and may not compete in a jump height division higher or lower than their proper height division.

All dogs that have not been officially measured for an **Agility Jump Height Card** may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial *or back-to-back trials* only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the **AKC Canine Partners** <sup>SM</sup> program may be eligible to enter all-breed AKC agility trials at the club's option effective April 1, 2010. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

**Junior Handlers** should enter their Junior Handler number on the front of this form.
